2018 Feather River Rock and Gem Show Application Silver Dollar Fairgrounds, Chico, CA

Dear Vendor,

It is our pleasure to invite you to join us for our 11th annual Rock, Gem and Lapidary Show next September 15-16, 2018. Set up for the show will be Friday, September 14 between 10:00 a.m. – 4 p.m. The show hours will be September 15-16, 2018 from 9:30 a.m. – 5:00 p.m. and 9:30 a.m. – 4:30 p.m. All 2018 applications will be considered on a first-come first-serve basis. We ask vendors to complete their signed application and payments as soon as possible to reserve your spot. Vendors may submit their application beginning September 16, 2017 with a \$100 deposit and completed application. The remaining balance is due by February 1, 2018 to reserve your spot. On February 2, 2018, we will open the remaining spaces to the waiting list. Your reservations will allow us to start planning next year's great show.

Inside vendor space consist of 6 foot long tables for \$75/table with a two table minimum per vendor requirement. Tables behind your sale tables are available at no charge. We will try to accommodate as best as possible. Chairs are provided.

To help relieve the overcrowding in the main building, we will be offering outside spaces. After setting up outside, the area will be fenced in and accessible through the main building only. Two sizes are available for vendors: 33 feet by 25 feet for \$250.00 and 20 feet by 25 feet for \$200.00. You may set up your space however you want as long as you do not infringe on neighboring vendors. You can bring your own tent and tables or rent tables from us for \$5 each.

Vendors will provide their own equipment needs. FRLMS assumes no liability for theft, pilfering, damage by fire, accident or injuries to persons or property. You must carry your own insurance policy. FRLMS has the right to refuse entry to anyone based on issues of balance of like-products, timeliness and thoroughness of application, and appropriateness to the event. Subletting of space is prohibited. Inside tables may be moved only at the discretion of the show chairperson. Substitution of space: If, because of fire, wind storm, or any other cause of condition beyond the control of FRLMS Inc., the Silver Dollar Fairgrounds becomes unavailable, the vendor hereby authorized FRLMS to assign the vendor in lieu of the space requested to find another location for the gem show, regardless of size or location, in such other building or space as may be procured for the show. If a vendor cancels after payment of fees, said fees are nonrefundable after four months before the start date of the show unless FRLMS or said vendor can find a substitute vendor(s) for equal fees.

FRLMS uses numerous media to promote the show and receives over 4,000 attendees and growing. Early payment permits us to advertise vendor's names during promotion. Advertisement includes social media, website, large banners, local festivals/events, postcards, television commercials, press releases, news articles, and more.
