2021 Feather River Rock and Gem Show Application Silver Dollar Fairgrounds, Chico, CA

Dear Vendors,

It is our pleasure to invite you to join us for our 15th Annual Rock and Gem Show September 18-19, 2021. The set up for the show will be Friday, September 17, between 10:00 a.m. to 4:00 p.m. **ONLY**. The show hours will be Saturday 9:30 a.m. to 5:00 p.m. and Sunday 9:30 a.m. to 4:00 p.m. All applications will be considered on a first-come, first-serve basis for our returning vendors. We ask all vendors to complete and sign their application with **full payment** and return to us by February 1 to secure the same spot you had at last show. We will open the remaining spaces not paid for to other vendors February 1.

Inside vendors space consists of 6 foot long tables for \$80.00/table, with a two table minimum per vendor. One table behind your sales tables is available at no charge. We will try to accommodate as best as possible. Chairs will also be provided.

To help relieve overcrowding in the main building, we will be offering limited outside spaces. After the initial set up outside, the area will be fenced with fairgrounds equipment and only accessible through the main building. You may set up your space however you want as long as you do not infringe on neighbor vendors or the walkway access to main building. You can bring your own tent/pop-up and tables. We will offer rented tables at \$5.00 a piece to be paid at time you fill out your application.

Vendors will provide their own equipment needs. FRLMS assumes NO liability for theft, pilfering, damage by fire, accident or injuries to persons or property. You **MUST** carry your own insurance policy. FRLMS has the right to refuse entry to anyone based on issues of balance of like products, timeliness and thoroughness of application and payment, and appropriateness of the event. **Subletting** of space is **prohibited**. If the Silver Dollar Fairgrounds becomes unavailable because of fire, wind storm, or any other cause of condition beyond the control of FRLMS Inc., the vendor hereby authorizes FRLMS to assign the vendor in lieu of the space requested to find another location for the gem show regardless of size and location available in another building space. If a vendor cancels after payment of fees, said fees are nonrefundable after June 1 unless FRLMS or said vendor can find a substitute vendor(s) for equal fees.
